The SPAAL supports an increase in penalties for assaults on police and other frontline emergency service workers, corrective service officers and other public officers.

## The definition of 'public officer' in section 340 of the Criminal Code should be expanded to recognise other occupations

Over the past 5 years the role of private security officer to protect Queenslanders from alcohol related crime, violence and anti-social behaviour, as well as deal with responsibilities related to the management and control of criminal organisations in and around licensed venues have led to increasing assaults on private security officers.

Private security officers play an integral role in the community in providing protection and safety for persons. Controlling the flow of people into and out of a venue or events presents a variety of potential risks to the health, safety and welfare of those responsible for crowd control. The primary role of crowd controllers employed to manage entry into events or venues is to ensure potentially troublesome or intoxicated people don't enter and are safely managed at that point. There are various risks to crowd controllers, such as aggressive or abusive behaviour, patron illness or patron traffic management issues and crowd controllers must hast the knowledge and training to deal with these situations.

We therefore propose that private security officers be included in the expanded definition of "public officer" in section 340.
